

#### **Submittal Data Sheet**

#### **Features**

- Meets NFPA 99 requirements.
- Valves shall be piped left to right.
- All valves are three-piece in-line repairable full port ball valves.
- Blow-out proof stem design.
- Accommodates 2.5" or 3" valve.
- Valves to have a working pressure of 600 psi (29 in/Hg vacuum).
- All valves cleaned for Oxygen service.
- Full color coded labeling (one of each medical gas provided).
- Provided with 1.5" diameter gauges.



The zone valve box shall be the Powerex ZVB series and must be installed and tested in strict accordance with NFPA 99 standards and or any other local codes before use.

The valve shall be three-piece, ball-type design with a forged brass body. Ball seats, stem seals, and stem washer shall be reinforced Teflon (PTFE), with Viton stem and flange o-rings. A blow-out proof stem shall be used and the valve shall have a maximum pressure rating of 600 psi (29in/Hg vacuum).

The valve shall be provided with type K copper tubing extensions to facilitate installation. Valve assembly shall be supplied cleaned for oxygen service in accordance with current CGA standards. The valve tube ends shall be capped to prevent contamination prior to installation.

The valve shall be provided with an identification bracket for the purpose of applying an approved medical gas identification label. A package of labels shall be supplied with each zone valve box for application by the installer.

Gauge shall be 1.5" diameter for monitoring pressure and vacuum.

Optional DISS gas specific sensor port is available for each valve.

The valve box shall be 14 gauge sheet steel construction painted to prevent rust. A single box shall house from one to seven valves. Box shall be supplied with an adjustable plaster flange .425" to 1.35" for easy mounting.



Shown above ZVB1H single valve box with 3" valve


Valve box assembly shall be supplied with a white extruded plastic frame which encloses an easily removable flexible window. The window shall be opaque white flexible plastic with clear windows for gauge and gas label viewing with a pull-out ring pre-mounted to the center of the window. The window shall not be replaceable while any valve is in a closed position. Window shall include the following statement: "MEDICAL GAS SHUTOFF VALVES. CAUTION: CLOSE ONLY IN EMERGENCY."




